#### RESOLUTION 13-04-06

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE LEHIGH ACRES FIRE CONTROL AND RESCUE DISTRICT, LEE COUNTY, FLORIDA; TO AMEND THE BUDGET FOR FISCAL YEAR 2012/2013; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Board of Commissioners of the Lehigh Acres Fire Control and Rescue District is desirous of amending the annual budget, and parts thereof, for the 2012/2013 fiscal year to update an unanticipated capital outlay expenditure.

NOW THEREFORE, be it resolved by the Board of Commissioners of the Lehigh Acres Fire Control and Rescue District, that:

### SECTION 1. INCORPORATION OF RECITALS.

The recitals set forth are true and correct and form a part of this Resolution.

#### SECTION 2. AUTHORITY.

The Board of Commissioners of the Lehigh Acres Fire Control and Rescue District is authorized to adopt this Resolution by Chapter 191, Florida Statutes, and other applicable laws.

## SECTION 3. AMENDMENT OF THE BUDGET FOR FISCAL YEAR 2012/2013.

The Board of Commissioners hereby amends the District's budget for the 2012/2013 fiscal year to adjust total grant revenue (due to the District getting denied its AFG Grant for a Class A Pumper truck). The total adjustment required is \$384,464. The fiscal year 2012/2013 budget will be adjusted as follows:

1. Grant Revenue (operating revenue) will be decreased by \$384,464; (Unassigned) Operating Reserve will be decreased by \$384,464.

The Board of Commissioners intends that all sections of this Resolution which contain typographical errors that do not affect the intent of this Resolution can be administratively corrected by the authorization of the District's Fire Chief, or his designee, without the requirement of having a corrected Resolution adopted by the Board of Commissioners.
