

RESOLUTION NO. 14-09-01

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE LEHIGH ACRES FIRE CONTROL AND RESCUE DISTRICT ADOPTING A TENTATIVE MILLAGE RATE FOR FISCAL YEAR 2014/2015, COMMENCING ON OCTOBER 1, 2014, AND ENDING ON SEPTEMBER 30, 2015; SETTING A FINAL PUBLIC HEARING DATE: PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Board of Commissioners of the Lehigh Acres Fire Control and Rescue District has properly noticed to hold its public hearing to set the tentative millage rate for the 2014/2015 fiscal year on Monday, September 15, 2014, at 5:01 P.M.

NOW THEREFORE, pursuant to Florida Statute §200.065, the Board of Commissioners of the Lehigh Acres Fire Control and Rescue District hereby adopts and sets the tentative operating millage rate of 3.0000 mills (\$3.0000 per \$1,000.00 of net taxable assessed value) for the fiscal year 2014/2015, which begins October 1, 2014, and ends September 30, 2015. The above stated tentative millage rate of 3.000 mills exceeds the rolled back rate of 2.7754 mills by 8.09%. The public hearing to adopt the final millage rate for the 2014/2015 fiscal year shall be held on September 30, 2014, at 5:01 P.M., at the Lehigh Acres Fire Station 104 Conference Room, 3102 16th Street SW, Lehigh Acres, Florida 33976.

This Resolution shall take effect immediately upon its adoption.
