#### RESOLUTION 15-04-02

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE LEHIGH ACRES FIRE CONTROL AND RESCUE DISTRICT, LEE COUNTY, FLORIDA; TO AMEND THE BUDGET FOR FISCAL YEAR 2014/2015; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Board of Commissioners of the Lehigh Acres Fire Control and Rescue District is desirous of amending the annual budget, and parts thereof, for the 2014/2015 fiscal year to amend (decrease) the Assigned Capital (Fund Balance) based on the purchase of three (3) ambulances...

NOW THEREFORE, be it resolved by the Board of Commissioners of the Lehigh Acres Fire Control and Rescue District, that:

## SECTION 1. INCORPORATION OF RECITALS.

The recitals set forth are true and correct and form a part of this Resolution.

## SECTION 2. AUTHORITY.

The Board of Commissioners of the Lehigh Acres Fire Control and Rescue District is authorized to adopt this Resolution by Chapter 191, Florida Statutes, and other applicable laws.

### SECTION 3. AMENDMENT OF THE BUDGET FOR FISCAL YEAR 2014/2015.

The Board of Commissioners hereby amends the District's budget for the 2014/2015 fiscal year to change (decrease) the Assigned Capital (Fund Balance). After this budget amendment, the Assigned Capital will change as follows:

1. Operating Reserves (Unassigned Fund Balance) will be increased by \$575,000; Capita I(Assigned Fund Balance) will be decreased by \$575,000.
