

RESOLUTION 23-09-02

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE LEHIGH ACRES FIRE CONTROL AND RESCUE DISTRICT, LEE COUNTY, FLORIDA; TO AMEND THE BUDGET FOR FISCAL YEAR 2022/2023; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Board of Commissioners of the Lehigh Acres Fire Control and Rescue District is desirous of amending the annual budget, and parts thereof, for the 2022/2023 fiscal year to adjust and/or reconcile various operating accounts, which are anticipated to be over budget.

NOW THEREFORE, be it resolved by the Board of Commissioners of the Lehigh Acres Fire Control and Rescue District, that:

SECTION 1. INCORPORATION OF RECITALS

The recitals set forth are true and correct and form a part of this Resolution.

SECTION 2. AUTHORITY

The Board of Commissioners of the Lehigh Acres Fire Control and Rescue District is authorized to adopt this Resolution by Chapter 191, Florida Statutes, and other applicable laws.

SECTION 3. AMENDMENT OF THE BUDGET FOR FISCAL YEAR 2022/2023

The Board of Commissioners hereby amends the District's budget for the 2022/2023 fiscal year to adjust and/or reconcile various operating accounts due to anticipation of the accounts being over/under budget. The total net change required is \$1,548,789. This change results from additions in revenues and additions in expenditures. The fiscal year 2022/2023 budget will be adjusted as follows:

1. Insurance (General) (expenditure) will be increased \$45,000; Assessment Fee Administration (expenditure) will be increased \$18,038; Paramedic Supplies (expenditure) will be increased \$40,000; Capital Buildings (expenditure) will be increased \$225,000; Capital Machinery and Equipment (expenditure) will be increased \$64,666; Interest on Loans (expenditure) will be increased \$217,329; Reserves - Assigned Capital (expenditure) will be increased \$938,756; Non-Ad Valorem Assessment (revenue) will be increased \$781,317; Interest (revenue) will be increased \$400,000; Interest 2022 Project Fund (revenue) will be increased \$314,600; Purchase Card Rebate (revenue) will be increased \$14,202; Proceeds from Insurance (revenue) will be increased \$31,970; and Cadets (revenue) will be increased \$6,7000.

SECTION 4. SEVERABILITY

If any section, subsection, sentence, clause, or other provision of this Resolution is held unconstitutional, inoperative or void by a court of competent jurisdiction, such holdings shall not affect the remainder of this Resolution.

SECTION 5. CONSTRUCTION AND EFFECTIVE DATE

This Resolution shall be liberally construed to affect the purposes hereof and shall take effect immediately upon its adoption.

SECTION 6. SCRIVENER'S ERRORS

The Board of Commissioners intends that all sections of this Resolution which contain typographical errors that do not affect the intent of this Resolution can be administratively corrected by the authorization of the District's Fire Chief, or his designee, without the requirement of having a corrected Resolution adopted by the Board of Commissioners.
